

AGREEMENT

(To be executed on Rs. 100/- Non Judicial Stamp Paper by parent/guarantor and submitted to the Principal at the time of admission)

- 1 This agreement is made between (hereinafter called the 'guarantor', which expression shall, unless excluded by the contexts of the meaning thereof, be deemed to include his heirs, executors, administrator and legal representatives) of one part and the Board of Governors, (hereinafter called the Board, which expression shall, unless excluded by the context or the meaning thereof, be deemed to include the Principal of the SMD Vidya Mandir, Khori Brahamnan, Raghunathgarh, Distt. Sikar (Raj.)) of the other part.
- 2 Whereas Boarder No. Son of (hereinafter called the student) is son/ward of the guarantor and has, at the request of the guarantor, been selected for admission to SMD Vidya Mandir for the purpose of receiving education, on the terms and conditions hereinafter appearing.
- 3 Now hereby it is agreed by and between the parties hereto as follows-
- a. That in consideration of the student being admitted by the Board of SMD Vidya Mandir for the purpose of the aforesaid education at the request of the guarantor, he/she, the guarantor, covenants with the Board that the student will attend the SMD Vidya Mandir regularly and will observe and comply with all the rules and regulations thereof for the prescribed period, and that he/she, the guarantor, shall pay to the Board regularly and promptly and whenever called upon to do so, all the fees and other costs as prescribed.
 - b. That the said student has been admitted on the understanding that the first term is probationary and that he will be required to leave the School at the end of the first term if the Principal is of the opinion that his capability and attainment do not reach the standard specified as requisite for admission.
 - c. That the placing of the students in different classes will be at the sole discretion of the Principal.
 - d. The principal can, at any time, in the interest of the school, have the student removed if, in the Principal's sole discretion, the student has failed to accept the discipline of the school and his continued presence is detrimental to the interest of the other students and/or the student fails to come up to the academic standard of his class and when detention in that same class would have made the student too old for the class.
 - e. That the said student if admitted as a boarder will not be permitted to change his status to a day scholar any stage for any reason whatsoever, as the seat allotment for boarders is done under a different criteria from day scholars.
 - f. That no fees will be refunded if the student is required to leave the School during term time for any reasons other than that of medical grounds.
 - g. That the Board will not be liable for any damages/charges on account of injuries, fatal or otherwise, which may be sustained by the student, at any time during his stay in School, while taking part in studies, sports, and extracurricular or any other form of activities of the school, within or outside the school premises. All expenses that may be incurred in the treatment of such injuries will be borne by the parent/guardian as provided in the rules of the SMD Vidya Mandir.
 - h. And that if there is any dispute as to the effect or meaning of these presents or in any way touching or arising out of these presents, the same will be referred to the sole arbitration of the Board of Governors, SMD Vidya Mandir, Khori Brahamnan, Raghunathgarh, Distt- Sikar (Raj.), whose decision shall be final.
 - i. That if the child breaks bound, i.e. leaves the School Campus without permission, the School shall not be held liable for any injury or harm that may befall on him and the child shall be asked to leave the School immediately..
